## INTERIM REPORT ON HOPE PROJECT 2022

### "Operation Feed the North"

The Chairman of Dr. Patience Selumun Tsavnande Foundation was introduced to Hope Project 2022 in September 2023. The Hope Project is a consortium of NGOs that are involved in the employment and empowerment of indigent Nigerians. The Foundation keyed into the project after consultation with BOT members since it is aligned with some of the objectives of the Foundation.

One of the major objectives of the Foundation is to enhance the capacity of indigent women by supporting them through engagement in entrepreneurship activities hence the reduction of poverty.

To start the process, the Foundation registered with the parent NGO; Ambience of Hope Exceptional Foundation (AHEF), with the sum of Two Hundred and Seventy Thousand Naira (N270,000.00) only, being the cost of registration forms. This puts the Foundation in a position to employ Ninety Staff made up of Thirty Consortiums.

A Consortium consists of a Manager, Secretary, and Treasurer (a copy of the form is here attached). These employments were advertised on the Foundation platforms and members who had candidates applied and those qualified were employed.

Though the project has not taken off, all the relevant documentations have been completed including registration with Special Control Unit against Money Laundering (SCUML). We are awaiting the roll call which will signify the start of the project.

The project will kick start with a grant for office accommodation for the Foundation followed by the full employment and empowerment processes.


